- 9. The Company's balance sheets and income statements audited by certified public accountants of our home country for the past three years (together with the balance sheet and income statement for the first half of the year, if the application is submitted in the second half of the calendar year);
- 10. English/Chinese translation of such insurance regulations of our home country as are specified by the competent authority of our home country;
- 11. Appraisal report issued by an insurance appraisal agency accredited by the competent authority;
- 12. Certificates issued by the competent authority of our home country, certifying that the Company has no record of major regulatory violations in the most recent 5 years;
- 13. A statement that where the R.O.C. branch of the Company is insolvent, the Company shall be jointly and severally liable for all the debts thereof; and
- 14. Other documents required by the competent authority.

Note: The aforementioned documents shall be submitted with the Chinese translation thereof unless, owing to special circumstances, such documents may not be translated into or recorded in Chinese. All the aforementioned documents except that referred to in Paragraph 6 shall be authenticated by the R.O.C. consulate or representative offices of other R.O.C. authorities in the home country of the Company.
